In Re: TWELFTH SUPPLEMENTAL ORDER CONCERNING COURT OPERATIONS RELATED TO COVID-19

GENERAL ORDER NO. 21-16

* * *

On March 20, 2020, and in light of the then-emerging COVID-19 pandemic, this Court imposed a variety of restrictions on access to its courthouses. See *In Re: Court Operations Related to COVID-19*, General Order No 20-03 (March 20, 2020). On May 27, 2020, the Court amended these restrictions to include the requirement that all persons over two years of age seeking entry to any of its courthouses wear a face covering or mask at all times within all public areas of the courthouses. See *In Re: Second Supplemental Order Concerning Court Operations Related to COVID-19*, General Order No 20-11 (May 27, 2020).

On May 14, 2021, consistent with the Interim Public Health Recommendations for Fully Vaccinated People issued by the Centers for Disease Control and Prevention (CDC), and in light of Governor Andy Beshear's indication that the Commonwealth of Kentucky would immediately follow these recommendations, the Court entered General Order 21-11, requiring only those individuals who have not been "fully vaccinated," as that term is defined by the CDC, to wear a face covering in order to enter a Western District courthouse.

On July 27, 2021, the CDC revised its Interim Public Health Recommendations for Fully Vaccinated People, recommending that fully vaccinated people wear masks while in public indoor settings located in areas of "substantial or high transmission" of COVID-19.¹ At present, this includes the vast majority of the Western District of Kentucky.²

Based upon the forgoing, it is hereby **ORDERED** that the following restrictions shall apply to all courthouses within the Western District of Kentucky that are located in areas of substantial or high transmission of COVID-19:

1. COURTHOUSE ACCESS. All persons over two years of age shall wear a face covering or mask at all times within all public areas of the courthouse, regardless of their vaccination status.

2. COURTROOM ACCESS. Subject to the discretion of the presiding judge, all persons over two years of age who are present during court proceedings shall wear a face covering or mask.

3. DAILY MONITORING OF PUBLIC HEALTH CONDITIONS. The Clerk is directed to check the CDC's COVID Data Tracker each week and to promptly notify the Chief Judge of the transmission status within each of the Court's divisions.

4. NOTICE. Due to anticipated variations in the public health conditions of the counties comprising each of the Western District's divisions, the Court shall communicate this Order's current applicability within each of its divisional courthouses by way of posted notices in said courthouses as well as notice posted prominently on its website at www.kywd.uscourts.gov.

This Order shall be effective upon entry. All provisions of previous General Orders concerning court operations that are not inconsistent with this Order shall remain in effect.
